HOUSING CRISIS WAS THE NUMBER ONE REASON CITED FOR SEEKING HELP IN THE FAMILY CENTERS WITH RENTAL ASSISTANCE, UTILITY ASSISTANCE AND DAMAGE DEPOSITS AS THE MAIN AREAS OF SERVICE.
